

# Commitment to Te Tiriti o Waitangi

Children and young people in particular must be cared for, treated with respect and their welfare placed at the centre of everything we do in the activity/sport.

Participant poaching shifts the focus from enjoyment of the activity/sport, to winning and losing. This is not what we are about. It can also harm

# **Policy**

### What is poaching?

Participant poaching is where a club/organisation representative approaches a participant, or for the purpose of encouraging them to join their club or compete for them. This can happen directly or indirectly, including face-to-face, by phone, text message, email or social media, or by asking another person to make contact for that purpose.

Participant poaching is not tolerated at

(insert name of organisation) as a method of recruitment.

It is also unacceptable for representatives of

(insert name of organisation) to entice or threaten a participant, or parent/guardian/whānau of a participant, who is registered with another club, for the purpose of encouraging them to join

(insert name of organisation) or compete for it.

#### What is not poaching?

It is not poaching where a participant, or their parent/guardian/whānau makes contact with

(insert name of organisation), seeking to join or compete for it, provided they were not influenced in any way, directly or indirectly, by any of its representatives.

Publicly advertising

(insert name of organisation)'s activity/sporting programmes or for participant recruitment/registration is not poaching.

Where

(insert name of organisation) wishes to recruit a participant from another club/organisation for a specific tournament or competition, it will make direct contact with that participant's club/organisation to seek permission. No representative will talk to the participant, or their parent/guardian/whānau, without permission from the club/organisation they are registered to.

Where a participant who is registered with another club/organisation indicates to

(insert name of organisation) they wish to join, or attend its trainings, tryouts, or other event,

(insert name of organisation) will advise that club/ organisation, where possible, but will not limit that participant's ability to attend.

#### **Breach**

Individuals who wish to report an alleged breach of this policy should follow the complaints procedure outlined in the Complaints Policy and Procedure.
